## STARS & ARRL Memberships

Membership in STARS is open to anyone with an interest in amateur radio. A license is not required. Membership applications may be obtained by sending a SASE to Judy Levan N2TEZ, 120 University BHd., Depew, NY 14043, from the newsletter editor of from bard members.

Annual Dues are payable on January 1 and are \$21 for a single membership, \$27 for family membership and \$8 for a student membership (hrough grade 12). The dues are pro-rated on a monthly basis for new members plus there is an initiation fee of \$5 when first applying to the club. For example, a new member joining in July would pay \$10.50 (6 months X \$1.75 per month) plus the \$5 initiation fee for a total of \$15.50.

### Busted Pirate Broadcaster Is Ham

A well-known ham who thumbed his nose at the FCC was among those caught up in a Tampa, Florida, sweep by federal agents to shut down unlicensed broadcasting operations there. L. Douglas "Doug" Brewer, KC4HAZ, a General license of Temple Terrace, Florida, was detained when armed agents moved in to close down the pirates and confiscate equipment. Brewer is the trustee of several Amateur Radio repeaters in Tampa.

Brever, 43, operated "The Party Pirate" from his home on 102.1 MHz. He told reporters that he was awakened November 19 at 6:30 AM by armed US marshals who handcuiffed him. According to news reports, federal agents seized equipment from his home studio and from a remote broadcasting yan that carried a "102.1 FM Pirate Radio" logo. They also dismantled a 150-foot tower. US marshals trucked away the equipment in a rental vehicle as Brever looked on.

Known on the air as "Craven Moorehead," Brewer is said to have taunted FCC officials on and off the air and has refused to pay a \$1000 FCC fine. Brewer has hinted that he plans to return to the airwaves. The Party Pirate was the subject of an article earlier this year in The Wall Street Journal. Brewer's Web site includes pictures of FCC agents taking field strength readings outside his house. telstar

## **Repeater Corner**

Happy Holidays everyone! It's been a long year, but we're now the proud owners of a new 2m repeater, a 440 repeater back in operation and co-located at Colden, a new shared controller for both, and a new 2m remote receiver system.

There were many ups and downs along the way, but these accomplishments were due to a solid group effort by many pople—those who helped with the work, those who helped with fund raising or contributions, and those who lent their moral support and patience throughout the year.

All equipment is fully functional except the remote receiver system, but by the time you read this, it may be up and running. Interface problems at Colden between the 440 link, the voter, and the 2m repeater are forcing me to bring all

the pieces home and put them on the bench to straighten out the interconnects.

During tests so far, the remote receiver at the Nike base has proven to be very sensitive—more so than expected. It should prove to be a welcome addition to 2m operations. Its great sensitivity will rule out timesharing of the 440 repeater input frequency as a link frequency for very long. Just too much link activity. A separate link receiver and frequency are in the works.

On another topic, with the bad weather already upon us, it's time to remind everyone of the preferred repeater operating procedures during those nasty drives to and from

work. First, remember that repeaters are mainly designed to help mobile and portable stations increase their range.

Because of that, base stations should lurk in the shadows and not dominate the repeater during the drive times (roughly 6-8 AM and 4-6 PM), when the mobiles/portables are out there and need the repeater's range-enhancing capabilities. Base stations should be monitoring and be ready to help if assistance is needed.

And if you are mobile or portable during those times, be considerate and don't carry on a long-winded rag chew, especially during bad weather. Waiting in the wings may be newer operators, or those who don't normally frequent the repeater, who would like to make a call, use the autopatch, or check on someone's progress.

They can be intimidated by others monopolizing the re-



peater, or playing quick-draw with their microphone switches. Keep your transmissions short and thoughtful, leave a pause between transmissions, and ask periodically if anyone else needs to use the repeater.

It's not that our repeaters are super busy all the time they're not. Active repeaters are a good thing, and we encourage you to use them. But activity does peak at certain times, and with bad weather or drive time operations, an extra does of thoughtfulness and consideration goes a long way.

If you'd like more information on proper operating procedures on repeaters, check these references: the ARRL Operating Manual; the FM and Repeaters section of Now You're Talking or the ARRL Handbook; or the Repeater Operating Practices section in the front of any ARRL Repeater Directory. If you don't have these, check the copies at the Nike Base, or, if you've been good, add them to your Christmas list!

### Arizona QRMer To Pay Up

Hams in Arizona are cheering, now that a man fined by the FCC for malicious interference and other rules violations has finally agreed to pay up. Last year, the FCC fined Timothy Harold Hoffman of Phoenix \$6000 for repeated violations, including interference to Phoenix-area repeaters. The violations were called to the Commission's attention by the Arizona Repeater Association's ARRL-sanctioned Local Interference Committee. Hoffman was cited for five specific violations, including transmitting on ham frequencies without a valid operator or station authorization, and willfully and maliciously interfering with ham radio communications. But, as Lance Halle, KW7LH, tells it, "it took a multitude of long distance calls by committee members, support from FCC personal, input from Congress, and the White House, to get a Notice of Forfeiture and then a federal court judgment" against Hoffman, which he called "one of the major interferers."

"The system does work," Halle said in alerting the ARRL to the October 26 judgment by US District Court judge Robert C. Broomfield. Hoffman will pay off his fine in increments of \$200 per month. "Spread the word! Maybe this will deter some of the would-be interferers."
