### LF-to-LF Transatlantic Amateur Contact is History

Amateur Radio history was made this month when amateurs in Canada and the UK completed what appears to be the first two-way transatlantic Amateur Radio exchange on 136 kHz. Larry Kayser, VA3LK, and Lawrence "Laurie" Mayhead, G3AQC, managed the LF feat using extremely slow

CW that featured 90second-long dits and 180second-long dahs. The two-way contact took two weeks to complete.

"We are the first to do a two-way QSO on LF across the North Atlantic as far as I am concerned,"



Kayser said. "We are the ones who put the stakes in the ground; others will build on what we have done."

The VA3LK-G3AQC contact began February 5 and was completed February 19 with the reception and confirmation of VA3LK's report by G3AQC. Kayser said the participants agreed in advance to a "firewall" between them for the duration of the contact and that all QSO information was exchanged over the LF radio link.

Mayhead said it was clear from the outset that, because of the relatively short band openings, he and Kayser would have to spread the contact out over several days. "It was not easy," he said. "I stayed up late most nights--3 AM on one occasion--changed blown fuses in my transmitter six times, and reconfigured my receiver to include a narrow filter because of interference that was desensitizing it." Kayser says he once had to climb the tower supporting his wire antenna in total darkness.

The UK has authorized amateur operation on 136 kHz, with special authorization and strict limits on radiated power. While Canada has not yet authorized general Amateur Radio operation on 136 kHz, Kayser and a few other Canadian

amateurs have received special authorization to experiment there.

Reception of weak LF signals typically is done using spectrographic software like ARGO or Spectran. Signals are transmitted using dual-frequency CW--or DFCW--or very slow-speed CW, also known as "QRSS." Using their particular brand of QRSS, Kayser calculated that it took nearly 70 minutes for him to send his call sign. "Certainly the information rate will improve," he said.

"We did the best we could with what we had to work with over the last two weeks."

G3AQC and VA3LK were using a combination of commercial and surplus equipment at their respective stations. G3AQC estimated his effective radiated power at 350 mW, while VA3LK said he might have been at the 5 W ERP level.

In October 1998, the ARRL petitioned the FCC to create two amateur LF allocations at 135.7-137.8 kHz and 160-190 kHz. The FCC has not yet acted on the request.

#### STARS & ARRL Memberships

#### Ohio Ham Stacking **Up FCC Sanctions**

Already under a short-term renewal sanction imposed last year for alleged deliberate interference, an Ohio ham now is being prohibited from all but VHF and the 30-meter band as a result of similar infractions.

The FCC notified General licensee Jeffrey J. Pipenur, WA8IKW, of Vandalia, on February 7, that his Amateur Radio license was being modified to prohibit operation on all HF bands except 30 meters until February 10, 2004. The FCC's action comes in the wake of continued allegations of deliberate interference on the part of the licensee.

Last March 1, after considering Pipenur's response to earlier FCC allegations of "deliberate interference, poor Amateur practice, and operation contrary to" FCC rules, the FCC set aside his renewal grant and renewed his license for one year. In his response, the FCC said, Pipenur did not deny the activity, apologized, and consented to the short-term renewal.

Pipenur's one-year renewal was granted with the condition that his license would be renewed if there were no further violations. Last November, however, the FCC confronted Pipenur with additional monitoring information and complaints alleging that he had deliberately interfered with ongoing amateur communications on 75 meters as recently as last September and October.

At that point, FCC Special Counsel for Amateur Radio Enforcement Riley Hollingsworth had threatened to designate Pipenur's license for a revocation and suspension hearing. Instead, Pipenur agreed to avoid a hearing and settle the matter by letting the FCC modify his license to restrict his operation to frequencies above 30 MHz with the exception of the 30-meter band.

Hollingsworth told Pipenur that his renewal would be granted with the restrictions stipulated. But he warned Pipenur that this was his last chance to avoid more serious sanctions.

"Please understand that if there are any substantial violations of these frequency restrictions or Commission rules during this three-year period ending February 2004, we intend to proceed towards revocation of your license for your station and suspension of your operator license for the remainder of the term," he said.

#### ORZ.COM

Many of you may have purchased CDs from QRZ which contain callsign information. They are usually attractively priced at hamfests, Strangely enough, the same company has a website (http://www.grz.com) which offers an amateur radio callsign database which can be searched for free. The free on-line database is even superior to that on the CD in that it is constantly being updated with new/changed data from the FCC.

The ORZ.COM website also offers many other features such as forums, swapmeet, radio mods, shareware, polls, practice amateur radio exams, ham clubs, etc.

A new feature is a state-by-state census summary of numbers of amateur radio operators by license class. The census as of

February 24, 2001 revealed the following information:

There were a total of 711,659 amateurs in the US (including possessions). The percentage breakdown by class showed: Extra 13.45%, Advanced 12.74%, General 19.50%, Tech Plus 15.14%, Tech 31.20% and Novice 7.96.

California leads the nation by far with 108,735 hams representing 15.28% of the nation. Second went to Texas with 43,456 or 6.11%. Florida claimed third with 42,101 or 5.92%. New York came in fourth with 31,313 or 4.77%.

#### Code-Free Technician Ticket Turns 10

Valentine's Day, February 14, marked the 10th anniversary of the elimination of the Morse code requirement to obtain a Technician license. For the first time, starting on February 14, 1991, applicants could obtain an Amateur Radio license in the US without having to take a Morse code examination. The ARRL was among several petitioners for a codeless license--quite a controversial issue at the time.

In putting out the welcome mat to the new class of Amateurs in his "It Seems to Us..." editorial in the February 1991 QST, ARRL Executive Vice President David Sumner, K1ZZ, predicted that five years down the road, "our first codeless amateurs will be providing personnel and leadership in local public service communications efforts from coast to coast." That prediction turned out to be right on the money. The Technician license has proved popular over the years, and Technician and Tech Plus licensees far outnumber other license classes today.

### D68C DXpedition at 126,000 Qs & Counting:

The D68C DXpedition to Comoros reports logging more than 4650 QSOs in the recent ARRL International DX Contest (CW), probably topping the current the Africa multi-two record by a significant margin. D68C has been active on 30, 17 and 12 meters as well as on 14 and 28 MHz RTTY and PSK31. The D68C will not do any satellite operation, as originally planned.

The team reports occasional high noise levels on the lower bands. "We are working all we can hear. Sometimes it is really hard to hear anything at all with all the static," said John Linford, G3WGV.



As of February 20, the team had 126,000 QSOs in the log, and Linford said he anticipates when all is said and done, the D68C operation will hold several new records, including total number of QSOs.--John Linford, G3WGV
