

ARRL Board Adopts Modified Novice Band Refarming Plan

The ARRL Board of Directors has adopted a modified proposal to refarm the Novice bands, now that the FCC no longer issues Novice licenses. The Board met January 18-19 in Fort Worth, Texas.

The ARRL Novice Spectrum Study Committee had proposed allowing Novice and Tech Plus (or Technician with

Element 1 credit) licensees to operate CW on General-class 80, 40, 15 and 10-meter CW segments at up to 200 W output. The panel recommended refarming the current Novice/Tech Plus CW subbands, in part to allow expansion of phone allocations on 80, 40 and 15 meters.



The Board approved a modified plan that would leave in place or slightly trim the amount of additional phone spectrum the committee had recom-

mended for 75 and 15 meters. The amended plan would drop the US phone band to 3725 kHz on 75 meters but leave it at 21,200 kHz on 15 meters. The original plan called for dropping both by 25 kHz.

The 75-meter proposal would expand the phone band by 50 kHz for Generals over the present allocation and by 25 kHz for Advanced and Extra licensees. On 15 meters, Generals would get another 25 kHz of phone spectrum, but phone privileges for Advanced and Extra class operators would stay the same.

Field Day 2002


The ARRL Field Day 2002 rules and packets now are available on the ARRL Web site http://www.arrl.org/ contests/forms/> as Adobe PDF files (ASCII files will be updated by next week). The ARRL has adopted rule changes affecting Field Day, including the addition of a "Get On The Air" (GOTA) station, which replaces the Novice-Technician station. Field Day 2002 will mark the first in which stations throughout the Americas have been invited to participate. All International Amateur Radio Union Region 2 countries -- North and South America -- may take part in Field Day, which takes place June 22-23 this year. STARS & ARRL Memberships

Membership in STARS is open to anyone with an interest in amateur radio. A license is not required. Membership applications may be obtained by sending a SASE to Judy Levan N2TEZ, 120 University Blvd., Depew, NY 14043, from the newsletter editor or from board members.

Annual Dues are payable on January 1 and are \$21 for a single membership, \$27 for family memberships and \$8 for a student membership (through grade 12). The dues are pro-rated on a monthly basis for new members plus there is an initiation fee of \$5 when first applying to the club. For example, a new member joining in July would pay \$10.50 (6 months X \$1.75 per month) plus the \$5 initiation fee for a total of \$15.50.

Telstar by E-mail

For several years we have made the Telstar available to club members by e-mail, if they chose to receive it that way. This has allowed the club to recognize significant savings.

We have used a plain text format for the e-mail version of the Telstar which conveys all the words but doesn't contain the graphics or pictures in the printed version.

We now have the capability of e-mailing members a full graphical version of the Telstar. The file will utilize the Adobe Acrobat format (.pdf). To view this, you will need the free Adobe Acrobat Reader software which can be downloaded at: http://www.adobe.com/products/acrobat/readstep.html. You will be able to view and print out the Telstar in full color.

FCC Completes Georgia ARRL VEC Exam Session Audit

The FCC has wrapped up an investigation into apparent irregularities at five ARRL VEC-sponsored Amateur Radio examination sessions in Georgia during 2000 and 2001. As a result of the probe, FCC Special Counsel Riley Hollingsworth said that several examinees would be called back for Element 1 (Morse code) retesting. In addition, the

ARRL VEC has discontinued volunteer examiner accreditation for all but two of the VEs involved. According to standard procedure, all VEs who might have been involved were suspended after the FCC investigation began last year.



"We have reviewed the examination documents and all relevant information, including that provided by the volunteer examiners and applicants," Hollingsworth said in a February 12 letter to ARRL VEC Manager Bart Jahnke, W9JJ. Jahnke called the apparent irregularities to the FCC's attention last June. The issues involved both exam sessions and instructional classes.

Initially focusing on the May 19, 2001, examination session in Statesboro, the FCC audit was expanded to cover the activities of the same group of VEs at Georgia test sessions in Claxton on February 19 and April 15, 2000, and in Statesboro on May 27, 2000, and February 17, 2001.

In a letter last summer to ARRL VEC, Hollingsworth said test session documents and other information indicated "alarming discrepancies in testing procedures." He said information before the FCC suggested that volunteer examiners at the May 19 Statesboro session used identical exam question sets and Morse text at several recent exam sessions in apparent contradiction of Amateur Service rules that prohibit administration of a "compromised examination." Hollingsworth also said it appeared that test candidates "had been shown or had access to" the Morse code answer key and that some VEs had taught classes using the same test editions later given at actual examination sessions.

Hollingsworth said that as a result of the FCC probe, eight examinees who obtained licenses as a result of the tests would be called in for Element 1 (Morse code) re-

examination, if they have not already re-tested.

The ARRL VEC has withdrawn accreditation for volunteer examiners responsible for the testing sessions at which alleged irregularities occurred as well as those of VEs present at a February 10, 2001, instructional class. The examiners are Ellie Waters, W4CJB; Cheryl L. Waters, W4CLW; Joanne D. Sharpe, KF4WFN; John W. Sharpe, WA4BE; Joseph A. Horne, N4ZAJ; George B. Grant, KF4WPU; Robert T. Jernigan, W4RTJ; Kathy L. Lanier, KD4MVY; Charles M. Aulick, KF4MLT; and Lawrence A. Lewis, K4RRR.

The ARRL VEC reinstated two VEs suspended during the audit--Charles F. Roberts, AI4A, and Marshall R. Thigpen Jr, W4IS.

Meanwhile, the FCC has yet to complete an audit of an ARRL VEC-sponsored examination session in Trumbull, Connecticut, last May. Eleven VEs remain suspended in that probe. The FCC is looking into whether one applicant had access to a Morse code answer key or submitted an answer sheet completed prior to the examination.

Amateur Radio Volunteers Supporting Olympics

Following months of planning and coordination, Amateur Radio is supporting the 2002 Winter Olympic Games, which got under way in Salt Lake City, Utah, February 8. Ham radio volunteers are assisting with security and remain available to provide back-up communication.

"The amateurs involved have assisted numerous local and federal agencies to develop a unique system that covers the entire Wasatch Front Area, providing communications to reach numerous Olympic venues 24 hours a day," said Utah ARRL Section Manager Mel Parkes, AC7CP. "Amateur Radio will be there should any of the primary frequencies fail or become unavailable."

According to Parkes, Utah Section Emergency Coordinator John Mabey, W7CWK, and Brent Thomas, AC7H, from the State of Utah Comprehensive Management Office began working on this effort over a year ago. A special public

safety organization--Utah Oly mpic Public Safety Command (UOPSC)--was created by the various local and national public safety organizations that provide the security necessary for the international event. Mabey, along with Davis County EC Hall Blankenship, KC7RAF; Kirk Boman, KD0J; Ed Cole, KB7EC; and Mike Youngs, KK7VZ, headed up the Amateur Radio effort to provide emergency



backup communication for the Olympic Security Command.

"UOPSC has now involved more than 200 Amateur Radio volunteers in Utah to support this critical security effort," Parkes said. In addition Amateur Radio volunteers are staffing a number of Olympic Security Command centers assisting local and national public safety organizations.

Nevada SEC Paul Cavnar, NN7B, says hams in his state remain on standby in case they're needed to help with communications. Cavnar said hams in Nevada, Idaho and Northern California also are prepared to assist in the unlikely event of a mass evacuation of the Winter Olympics site.

"The hard work and dedication by all these Amateur Radio operators will certainly contribute to a very successful and safe Winter Olympic Games," Parkes said.
